#### PART B. CV SUMMARY

Luisa Martín Rojo is Full Professor of Linguistics at the Universidad Autónoma de Madrid (UAM). She has worked for many years in the fields of interactional sociolinguistics and pragmatics and has taught a wide range of courses on multilingualism, intercultural communication, language and education, and linguistic landscapes. Her research has focused on how language policies and practices produce social stratification and exclusion. In recognition of the originality of her work, the project "Assimilation or integration? Dilemmas of language policies in response to migration processes" was awarded second prize in the Caja Madrid III Centenary Social Research Prizes in 2003. Since 2000 she has been the Director of the MIRCo interdisciplinary research team, which was transformed in 2021 into the MIRCo-UAM Interdisciplinary Research Centre on Multilingualism, Discourse and Communication.

Over the last ten years, she has been the principal researcher of seven national and international projects funded by the Spanish National Research & Development Programme (3), the Department of Education of the Community of Madrid (2), and the UAM/Banco Santander Programme (2), as well as by local administrations and health institutions, with a total budget of around €250,000. In addition to directing the MIRCo research centre, she has had a leading role in major research projects for the last 5 years: 1) as a principal researcher of a multi-site research project in four Spanish regions "Critical Sociolinguistic Consciousness and Speaker's Agency: Action-Research for Sociolinguistic Equality" (€60.500); and 2) as IP or co-researcher of three Marie Skłodowska-Curie Actions, within Horizon 2020; 3) as part of the Steering Committee and coordination of the Immigration Working Group Leader of Cost Action IS1306 "New Speakers in a Multilingual Europe: Opportunities and Challenges" (€507,909.57), coordinating more than 50 researchers from 28 countries. She has also led major projects as Director of the Discourse Observatory of the EDiSo Iberian Association of Studies on Discourse and Society, including citizen science projects. In the last ten years, she has published more than five articles in Q1, four books for international publishers in the humanities and social sciences, and more than 30 widely cited chapters (cf. Google Scholar). She has published frequently in prestigious publishing houses, most notably in the volumes "Constructing Inequality in Multilingual Classrooms" (Martín Rojo, 2010) (see also Martín Rojo & Mijares, 2007; Martín Rojo, 2008; Martín Rojo, 2012; Martín Rojo, 2013; Márquez Reiter & Martín Rojo, 2016), and more recently in "Occupy: The Spatial Dynamics of Discourse in Global Protest Movements" (Martín Rojo, 2016) and "Language and Neoliberal Governmentality" (Martín Rojo & Del Percio, 2019). Her 30 years of research experience have been positively evaluated by the Spanish Research Quality Agency, despite two significant interruptions (in 2008 due to a serious car accident and in 2015 due to illness): 5 research terms (1988-1994; 1995-2000; 2001-2006; 2007-2012; 2013-2018), and 1 of transference. Her academic leadership has also been recognised by the CUNY Graduate Center Distinguished Visiting Professorship Award (2015-2016). She was also a visiting researcher under a Salvador de Madariaga/Fullbright Programme at the University of New York (2011) and King's College London (2012). In terms of social and academic commitment, she has been a national expert representing Spain in the Rapid Response and Evaluation Network (RAREN) of the European Monitoring Centre on Racism and Xenophobia. She has extensive experience in the training and formation of junior researchers: she has supervised 16 PhD dissertations, whose authors have received the Outstanding Ph.D. Dissertation Award, had their dissertations internationally published, and have developed outstanding careers at European and American universities. Currently, she is a member of the European Science Foundation evaluation committee, and of the editorial boards of the journals Discourse & Society (from 1998; Q1), International Journal of Sociology of Language (from 2020; Q1), Journal of Sociolinguistics (2020; Q1), Critical Discourse Studies (from 2000; Q2), Discurso y Sociedad (from 2004; Q3), Journal of Multicultural Discourses (from 2008; Q1), and the new journals (ranking not available yet) Linguistic Landscapes (from 2015) and Language, Culture and Society (from 2017), as well as John Benjamin Book series, Discourse Approaches to Politics, Society and Culture (from 2000). She has also been a member of international committees such as the International Pragmatics Association (IPrA) Consultation Board (two terms: 2006/12; 2012/17); and of the Research Collegium for Language in Changing Society (RECLAS), University of Jyväskylä & Finnish Ministry of Education (2016/2018).

Finally, she also participates in assessment committees such as European Science Foundation College of Review Panel Members (2010-date); Research Projects Selection Committee in Philology, and Spanish Ministry of Education (2006-date). She is a member of the evaluation committee of ANECA – National Agency for Quality Assessment and Accreditation of Spain for the evaluation of research periods and researcher staff.
